Holy Name of Mary Religious Education Policies MUST RETURN WITH APPLICATION
We ask that you carefully read and sign this page and discuss the importance of these rules with your child

I have read and will abide by the following policies _____(Parent) and _____(student)

The Religious Education program at HNM parish offers instructions to the children who attend public and private (non-parochial) school whose families are enrolled parishioners at Holy Name of Mary Parish. An eight year sequence of formation is offered (from 1st grade to 8th grade) and all Catholic children of the parish are expected to participate and attend Religious Education continuously from grade 1 through 8 grade.

Following is a list of the behavior expectations required of every child who attend the program:

- 1)Weekly attendance to mass: every child is expected to attend weekly mass as part of their Faith Formation.
- 2)Weekly class attendance: If for any reason your child is not able to attend class one week he will be asked to complete the lesson at home and present it to the catechist upon returning to class. This work will be required in order to move to the next grade level.
- 3)Children are expected to arrive to classes on time.
- 4)Unacceptable Behavior includes the following:

- Fighting
- Defiance of staff
- Use of profanity
- Refusal to prepare assignments
- Possession of dangerous objects
- Possession of tobacco or controlled substances
- Damage of property(if your child destroys property it must be paid by the parent)
- Leaving the building/premises during class without permission
- Habitual tardiness and absenteeism
- Cheating
- Using cell phones during class (If your child uses their cell phone in class, it will be taken away and you will need to come into the office after class to pick it up.)

If a student incurs in unacceptable behavior the following steps will take place:

First time: student will be sent to the office to speak to the Director

Second time: parents will be called and asked to speak with their child about their behavior

Third time: parents will be called to pick up their child immediately. If misbehavior continues the child will be removed from the program pending a meeting with the director, pastor and parents.

Tuition/Fees: no child will be enrolled in a class until the office receives the tuition fees. If there is a financial burden please contact our office.
